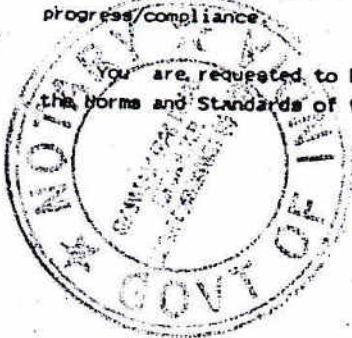
The approval has been subject to fulfillment of Specific conditions listed at Annexure 1 and Norms and Standards & general conditions as stipulated by Council.

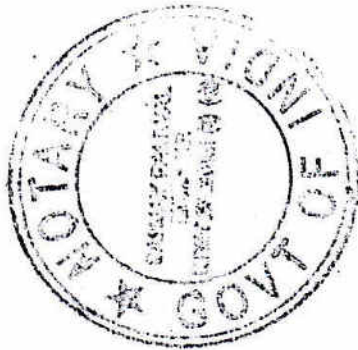
